Scrum Agile Project Methodology was employed for the project management process, with ASP.NET & MSFT SQL Server.

- TIPS is the Technical Innovation and Professional Services, a national service provided by the U.S. Office of Surface Mining Reclamation and Enforcement, which provides off-the-shelf scientific and engineering modeling software to the state, tribal, and federal offices that administer the Surface Mining Control and Reclamation Act of 1977. Using their existing web site content as a starting point, we collaborated with OSM team leads and stakeholders using an Agile project management methodology to develop a full-scale web application using Microsoft ASP.NET 4.0, ASP.NET MVC, and SQL Server. We also provided system training based on contract specs and remote technical assistance in site launch and system implementation in their hosting environment.
